Sir,

With reference to your application dated 3-6-1981 on the aforesaid subject, the undersigned grants composite recognition from class I to VIII (without aid) to your school w.e.f. next academic session i.e. 1982-83, with the following terms and conditions:-

1. That the school will admit students without any discrimination of caste and creed.
2. That the school will abide by the rules and regulations of the Delhi School Education Act and Rules, 1973 and instructions issued there under from time to time.
3. That the qualified staff will be appointed as per the present norms of the Directorate of Education, Delhi.
4. That the head of school is appointed/promoted as per norms and recruitment rules prescribed by the Deptt.
5. That the management of the school will spend Rs. 3000/- for strengthening the school laboratory.
6. That the management of the school will spend 5000/- for strengthening the existing school library and reading room facilities be provided to the statements, as well as to the teachers.
7. That the fees will not be enhanced without the prior permission of the Director of Education, Delhi and no development fee will be charged from the students.
8. That the school will follow the syllabus/books prescribed by the department.
9. That no employee of the school shall be dismissed or reduced in rank nor shall his/her services be otherwise terminated without the prior permission of the Director of Education, Delhi.
10. That the management of the school will pay the salary to the staff through crossed cheques.
11. That the regular scales of pay, allowances, medical facilities, pension etc.

17. All facilities under rules 50 and 51 shall be made available in the institution.

18. That the necessary adequate accommodation and furniture will be made available to all classes. The number of sections in the school should not exceed the class rooms of appropriate size (24'x20').

19. That the managing Committee will take immediate steps for the construction of the school building after obtaining the land from D.D.A.

That the school shall meet the additional liability of Senior Secondary classes.

That adequate sports material shall be purchased and made available to the students.

That all the facilities prescribed under Rules 51 of D.S.E.R.-1973 shall be made available to the school.

Proper facilities for drinking water, toilets and first aid be provided. Separate toilets for boys, girls and separate toilets for ladies and gents staff be also provided.

That the school shall strictly abide by the provisions of Section 10(1) of the D.S.E.A.-1973.

That the school shall not run any un-recognised classes or any non-educational activities within the school premises.

Fresh health certificate from M.C.D. be obtained and produced to the Education Officer for verification.

That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.

13. That adequate and sufficient accommodation of 10 sq.ft. per student shall be provided for the class room. The minimum size of the class room should not be less than 300 sq.ft. (20' x 15') atleast to accommodate 30 students per class/section. The rooms should be properly cross ventilated. The rooms should not be closed from three sides.
14. The Managing Committee of the school shall not increase/enhance fee during the ensuing academic session without the prior approval of the Director of Education which is a mandatory requirement under sub-section (3) of Section 17 of D.S.E.A. 1973.
15. That the Management of the school shall create a Reserve Fund equal to minimum three months salary of the staff in the joint name of the Director of Education and the Manager of the school.
16. That the school shall comply with the norms of the C.B.S.E. for affiliation fee/examination purposes.
17. That report about the fulfilment of the above conditions shall be sent to the Education Officer within six months.
